## Personal Information Collected through the Zephyr™ Performance Website and How We Use It

You are not required to provide any Personal Information to use parts of our website. However, other parts of our website -- including those that have tools enabling you to get more personalized information -- require you to create an account or register in order to access particular tools or services. For example, by creating an online account, you will be required to provide certain Personal Information in order to gain access to a variety of specialized information. The Personal Information collected will be limited to what is necessary to provide the level of services requested. We collect Personal Information when you register for an account. This information is maintained at all times within the United States and securely stored in the cloud through our account with Amazon Web Services. We use the Personal Information that you provide in various ways, including responding to your questions, providing you with the specific services you select, showing you website content, and sending you emails that may be of interest to you. Medtronic may transfer your Personal Information to an affiliate, subsidiary or successor to the business to which such information is associated. Medtronic obtains various types of services, such as information technology, email delivery and data analysis, from its affiliates, subsidiaries, and other trusted business partners.
